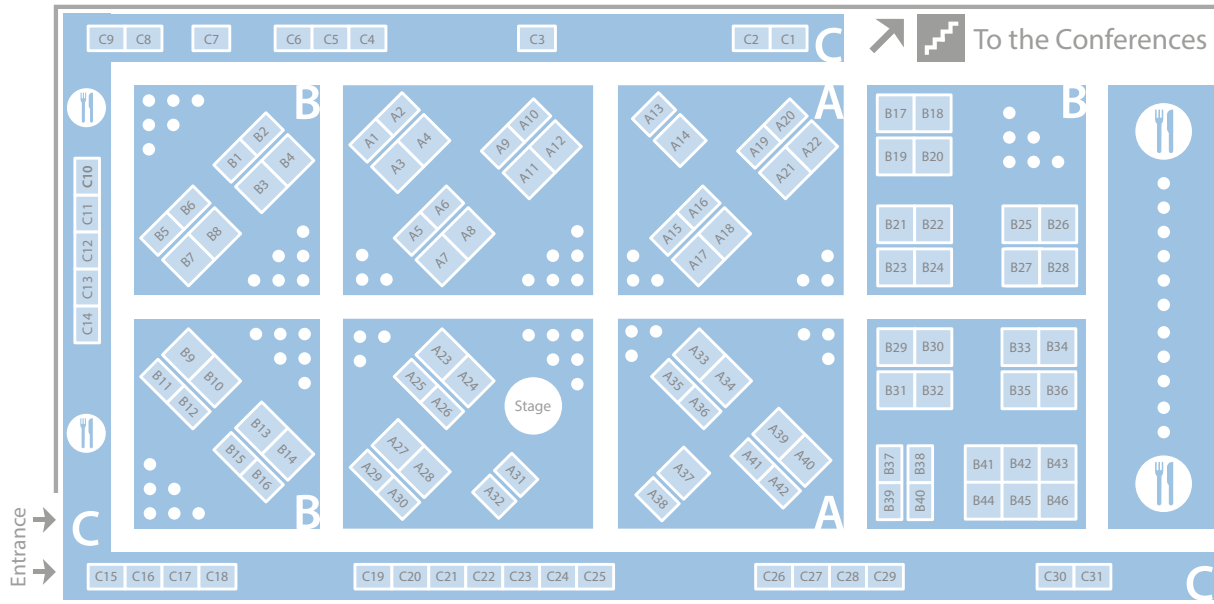
Sponsoring at PharmaTechnica Expo
